fire as they were moving through an area in She and her fellow soldiers fought Afghanistan. valiantly as she not only returned fire but managed to save two of the four herself that were wounded in the firefight. Sgt. Murphy, or "Murph" as she is called by her friends, used to be a paralegal in the Army, but recently was trained to be a nurse. She stated in an email to friends that she has been involved in 3 rocket/mortar attacks, 3 small arms attacks, and has treated 3 combat wounded on 2 different occasions. One of the small arms attacks she was involved in was when her group was ambushed by the enemy. They were attacked with automatic weapons, RPG's

(rocket propelled grenades), and hand grenades. This isn't something that is just happening to people in the distance... this is happening to our families and our friends. Just a couple of

weeks ago, South Carolina had its first National Guard casualty, and that certainly hit home amongst myself and all my friends that I serve with. Please remember those soldiers who have given so much over their lives, and also the ones who continue to give in service today, when Veteran's Day rolls around this Thursday.

I will see you at lunch this coming Monday, so have a great week!

Last year, the Club raised over \$70,000 for the Carolina Children's Home, while contributing to more than thirty other local charities including Camp Sertoma, Home Works, Sistercare, Work In Progress, the Sexual Trauma Services Center, the Interfaith Thanksgiving dinner, the Good Neighbor Fund, Children Unlimited, Project Take Heart, and Rolling Readers, among others.

The Club typically raises funds by participating in various projects throughout the community, such as selling concessions during concerts at the State Fair and the Three Rivers' Music Festival, parking cars prior to football games at the University of South Carolina, selling smoked Christmas turkeys and hams, and seeking monetary pledges in an annual fundraising drive to benefit the Carolina Children's Home.

Philosophy of Giving—The Club's members are volunteers who pay monthly dues to finance their meetings and social events, thereby enabling the Club to donate one-hundred percent of its fundraising monies to worthy charities.

Numerous groups have recognized the Club's generosity, compassion, and result when members come together to complete a fundraiser or service project. In fact, the Club's members and their families enjoy a wide array of social activities together, including boat cruises, golf tournaments, oyster roasts, football games, and an annual installation banquet during which the Club inducts its new president and board members and celebrates its storied history.

In a perfect world with no pain, suffering, or poverty, our communities would have no real need for an organization like The Columbia Sertoma Club.
